No risers available. No barriers available.

### Sound limit

Max. average sound level of 103dB(A), will be measured/logged according to national covenant.  
Wednesday - Sunday: Sound restrictions until 21:30.

### Backline

We do not have any backline at the venue.  
When backline rent is in the deal, we need backline specs well in advance.  
In case of 2 bands or more: backline share is a must and is part of the deal.  
Backline cannot stay overnight in the venue.

### Pyrotechnics and decor

Pyro, fire, sparkulars, confetti, glitter, flutterfetti, snow, foam, bubble machines, frogs, etc. are not allowed.  
All plans regarding decor need to be discussed in advance.  
When used it needs to comply with fire safety regulations.

### No smoking
